Subject:- Termination of Veterinary Assistant Surgeon of Sheep Husbandry Department, Jammu.

Ref:- Letter No. DSH/Esstt-Gaz/F-278/2021-22/4326 dated 22.06.2021 from Director Sheep Husbandry Department Jammu.

Whereas, on the basis of recommendation of J&K Public Service Commission vide their communication No. PSC/DR/VAS/2019 dated 05.04.2019, Dr. Amandeep Singh appointed as Veterinary Assistant Surgeon in the Sheep Husbandry Department, Jammu (State Cadre) vide Government Order No.59-ASH of 2019 dated 22.04.2019 was on probation for a period of 05 years under the provision of SRO-202 of 2015; and

Whereas, the District Sheep Husbandry Officer, Samba vide his letter No.DSHOS/Tech/2020-21/998-1001 dated 19.11.2020 has intimated that Dr. Amandeep Singh has proceeded on 03 days casual leave w.e.f 10.11.2020 to 12.11.2020 by simply dispatching an application to this office without seeking prior permission for leaving headquarter and that too, when Model Code of Conduct was in force due to DDC Elections;

Whereas, he was asked to resume his duties by District Sheep Husbandry Officer, Samba vide his letter No.DSHOS/Esstt/2020-21/1028-30 dated 27.11.2020;

Whereas, the Director Sheep Husbandry, Jammu vide letter No.DSHJ/Esstt-Gaz/F-278/2020-21/17581 dated 10.03.2021 served 1st Notice to Dr. Amandeep Singh, VAS to resume his duties within a week's time through speed post on his home address and the Notice was also published in Newspaper Dainik Jagran on 07.04.2021 but the officer failed to resume his duties. Accordingly, 2nd Notice was served to the absentee vide No.DSHJ/Esstt-Gaz/F-278/2021-22/1451-55 dated 17.04.2021 to join his duties, but despite repeated notices, the officer did not report and failed to attend his duties; and

Whereas, vide Government Order No.99-ASH of 2021 dated 12.07.2021, Mr. Krishan Lal, KAS, Director, Sheep Husbandry Department, Jammu was appointed as Inquiry officer to conduct the enquiry with regard to un-authorized absence of Dr. Amandeep Singh, Veterinary Assistant Surgeon, Sheep Husbandry Department, Jammu from duties and furnish the detailed report along with his recommendations to the Administrative Department within 07 days.

Whereas, the Director, Sheep Husbandry Department, Jammu vide their letter No.DSH/Esstt-Gaz/F-278/2021-22/6370 dated 23.07.2021 has submitted the inquiry report enclosing resignation tendered by the Dr. Amandeep Singh, Veterinary Assistant Surgeon with recommendation that the probationer Dr. Amandeep Singh, VAS Sara Tehsil & District, Samba may be discharged from the services as per the provision of SO.192 dated 17.04.2020; and

Whereas, as per Rules-4 sub-para (1) (b) of S.O. 192 of Jammu & Kashmir, Probationer (Condition of Service, Pay and Allowance) and Fixation of Tenure rules, 2020. "At any time before the expiry of the period of probation, the appointing authority may: -

(b) at his discretion, terminate the probation of a probationer and discharge him for Service".

Whereas, the case has been examined in view of the rules in vogue and it has been decided that Sh. Amandeep Singh, VAS R/o Sara Tehsil & District, Samba be terminated from the services of Sheep Husbandry Department, Jammu on the recommendations of Inquiry Officer.

Now, therefore, in terms of Rule-4 of S.O 192, the probation of a probationer Dr. Amandeep Singh, Veterinary Assistant Surgeon is hereby terminated and he is deemed to have been discharged from Services of Sheep Husbandry Department w.e.f. 13.11.2020.
