**Subject:- Accord of Administrative Approval for Construction of Dairy Goat Farm at Arin Dardpora District Bandipora amounting to Rs 836.69 lac.**

Administrative Approval is hereby accorded for **"Construction of Dairy Goat farm at Arin-Dardpora District Bandipora"** to the tune of **Rs. 836.69 lac** (Rupees Eight Crore Thirty Six Lakh and Sixty Nine Thousand Only) in favour of the Director Sheep Husbandry, Kashmir.

The above said Administrative approval is subject to the fulfillment of all codal formalities, procedural norms and the conditions laid by Development Commissioner(Work) vide No.PW/DCW/DB/07/2021 dated 01-01-2021:-

1. That the proposal is strictly devised and designed as per latest relevant I.S code and specification of PWD/CPWD and same is authenticated and proof checked by the competent authority. While designing, latest HFL has to be taken into consideration for flood prone locations and adequate provisions in design need to be incorporated for making structures resistant to earthquakes.
2. That the Electrical and Mechanical Components are authenticated and technically vetted by the Competent Authority of the relevant field.
3. That the standard specifications are followed as per CPWD, NBC and I.S Standard.
4. That the specifications as defined in CPWD PLINTH AREA RATE SCHEDULE for the type of structures, proposed in PPR are followed and adopted for the execution of works.
5. The rates for the items, not covered in JK SSR or any other relevant schedule, shall conform to Analysis of rates based on authentic Data Book, to be computed and approved by the competent authority well before invitation of tenders in accordance with set codal procedures.



6. The Lump-sum provisions, either in term of percentage or fixed as made for certain components of PPR are provisional and shall be subject to detailed estimates based on actual details/requirements and relevant rates, to be framed and approved by the competent authorities' well before invitation of tenders in accordance with set codal procedures.
7. That e-tendering mode is followed for fixation of the award of contract for execution of the project. Fragmentation of project, while tendering, is not allowed.
8. that no creation of posts under both Revenue and Capex accounts are involved.


