Sanction is hereby accorded to advance drawal of ₹6.87 lakh (Rupees Six Lakh and Eighty Seven Thousand) only in favour of Director Sheep Husbandry Jammu under the project "Reorienting Priorities, Self Sufficiency in Mutton Production" for supply of Sponges and Plunger from ICAR- Central Sheep and Wool Research Institute (CSWRI), Avikanagar, Rajasthan during the current financial year 2023-24 as per the following breakup:-

The advance drawal is however, subject to following conditions: -

- 1. The Department shall follow provisions of GFR for the said procurement & the scheme guidelines.
- 2. No diversion of funds is allowed and there shall be no re-appropriation at any level and no liability should be created.
- 3. The funds shall be utilized for the purpose for which it is meant for and expenditure shall be incurred strictly under rules after completing all codal formalities, procedural norms, financial rules and regulations issued by the Government from time to time.
- 4. Accounts Officer, Directorate of Sheep Husbandry, Jammu shall vouchsafe the utilization of funds as per codal procedure and the UC's / Red Accounts of the advance drawl shall be furnished to the concerned quarters within stipulated time.
- 5. The funds are available for the current financial year, 2023-24 for said purpose under relevant Head of Account / Scheme.



- It must be ensured that there is no overlapping of funds from any other sources such as SDRF, District Plan, CSS, BSDP, PM's Package, CDF, MPLADS, etc.
- 7. The funds shall not remain idle in the Bank Account.
