

Subject: - Advance drawal of Rs. 147.995 Lakh under CSS, Pradhan Mantri Matsya Sampda Yojana (PMMSY).

Sanction is hereby accorded for advance drawal of ₹147.995 lakh (Rupees One crore forty seven Lakh ninety nine thousand and five hundred) only in favour of Director, Finance Animal and Sheep Husbandry and Fisheries under Centrally sponsored scheme Pradhan Mantri Matsya Sampda Yojana (PMMSY) for construction of Low Cost Houses and establishment of RAS unit for scheduled Tribe category during the current financial year 2023-24.
