On the recommendations of the J&K Services Selection Board, forwarded by the General Administration Department vide above quoted references, sanction is hereby accorded to the appointment of following 04 (four) candidates as Class IV (Multi Tasking Staff) against the vacant District Cadre posts of MTS (Class-IV) in the pay level SL-1 (14800-47100) in the Animal Husbandry Department, Kashmir with immediate effect:-

The appointees shall report to the Director, Animal Husbandry, Kashmir within period of (21) days from the date of issuance of this appointment order. The candidates, who fail to join within the stipulated time, shall forego their right to appointment and the same shall be deemed to have been cancelled *ab-initio* without any further notice.

The appointees shall be allowed to join, only on the production of the following certificates (in original) to be verified subsequently:-

- i. Academic/qualification Certificates.
- ii. Matriculation/Date of Birth Certificate.
- iii. Health Certificate from the concerned Chief Medical Officer of the District.
- iv. Domicile Certificate issued by the Competent Authority.
- v. Certificates from the District Industries Centre (DIC) and District Employment & Counseling Centre to the effect that no loan under any self employment scheme has been availed by the appointee.
- vi. Valid relevant category Certificate, if any applicable.

The appointment of the above candidates shall further be subject to the following conditions:

- a. The clearance received from the Criminal Investigation Department, J&K is provisional and it shall be mandatory for the appointee to fill in the Verification Rolls (V-Rolls) through the online mode under the Electronic Employment Verification System (EVS). Any false information provided by the appointee or an adverse finding received subsequent to the V-Roll submitted electronically shall result in cancellation of appointment without any further notice.
- b. Each appointees shall furnish an Undertaking in the shape of an Affidavit as per Annexure-I to this Order.
- c. The cadre/Departments allocated by appointing authority/SSB shall not be changed under any circumstances by any authority/Department.
- d. The salary of the appointee(s) shall not be drawn and disbursed to them unless the satisfactory reports in respect of genuineness of Qualification/Date of Birth/Relevant Category Certificate and final Character & Antecedents report is received from the concerned Authorities/Agency.
- e. The appointees shall be on probation for a period of two years.
- f. The appointment of the candidates shall be governed by the "New Pension Scheme" as notified vide SRO-400 of 2009 dated 24.12.2009.
- g. The inter-seniority of the appointees in the J&K Animal/Sheep Husbandry (Subordinate) Service shall be determined as per the J&K Civil Services (Classification, Control and Appeal) Rules, 1956.
- h. The appointment of the above appointees shall be cancelled *ab-initio*, if it is found that they possess higher qualification than the prescribed one at any stage and he/she shall also be liable for criminal prosecution under law.
- i. The appointment of the above appointees shall be subject to outcome of writ petition(s), if any, pending before Competent Court(s) of law.




