Whereas, on the basis of recommendation of JK Public Service Commission vide No.PSC/DR/VAS/2018 dated: 22.02.2019, among others, Dr Zaffer Iqbal, was appointed as Veterinary Assistant Surgeon in Animal Husbandry Department, Jammu/ Kashmir (State Cadre) vide Government Order No. 40-ASH of 2019 Dated: 01.03.2019 and subsequently the officer was posted as Poultry Extension Officer, Poonch vide Govt. Order No: 66-ASH of 2019 dated: 14.05.2019; and

Whereas, Dr. Zaffar Iqbal ,Veterinary Assistant Surgeon was appointed in the department on regular temporary basis and was on probation for a period of 02 years; and

Whereas, pursuant to his appointment as Naib Tehsildar in Revenue Department, the Veterinary Assistant Surgeon has submitted his resignation to Director, Animal Husbandry, Jammu and the Director, Animal Husbandry Jammu vide letter No DAHJ/Adm-49/30884-885 dated: 17.03.2022 forwarded the copy of the resignation tendered by the Veterinary Assistant Surgeon to the Administrative Department with the request to accept his resignation w.e.f 27.05.2020; and

Whereas, as per Rule 4 sub-para (1) (b) of S.O 192 Jammu & Kashmir Probationer (Condition of Service, Pay and Allowance) and Fixation of Tenure Rules, 2020 " also provides that:-

"At any time before the expiry of the period of probation, the appointing authority may:

- (b) at his discretion, terminate the probation of a probationer and discharge him from service".***

Whereas, the case has been examined in view of the rules in vogue and it has been decided to accept his resignation and discharge him from the services of Animal Husbandry Department, Jammu/Kashmir .


