Whereas, vide Government Order No. 89-ASH of 2019 dated 08.07.2019, Dr. Sheikh Mohd. Usman was appointed as Veterinary Assistant Surgeon in Animal Husbandry Department, J&K and was working as Veterinary Assistant Surgeon at LDC Sangrambhatta; and

Whereas, Dr. Sheikh Mohd. Usman, Veterinary Assistant Surgeon submitted his resignation in the office of Chief Animal Husbandry Officer, Kishtwar on 26.02.2024 on the grounds that he has been appointed for the post of Assistant Professor, Veterinary Technology in Higher Education Department; and

Whereas, the Director Animal Husbandry, Jammu vide No. DAHJ/Adm-153/2022-05/7015 dated 12.06.2024 asserted that there is no RDA/Vigilance Case or outstanding pending against Dr. Sheikh Mohd. Usman, Veterinary Assistant Surgeon.

Now, therefore, in terms of Rule-200 of J&K CSR Vol-I, other enabling provisions and on the recommendations of Director, Animal Husbandry Jammu, resignation of Dr. Sheikh Mohd. Usman, Veterinary Assistant Surgeon is hereby accepted and is discharged from the J&K Animal Husbandry (Gazetted) Services w.e.f. 26.02.2024.
