**Whereas,** Dr. Shabir Ahmad Bhat, Veterinary Assistant Surgeon had applied for the post of Assistant Professor, Veterinary Technology in Higher Education Department through proper channel; and

**Whereas,** Dr. Shabir Ahmad Bhat, Veterinary Assistant Surgeon tendered his resignation in the office of Chief Animal Husbandry Officer, Kupwara w.e.f. 21.02.2024 on the grounds of his appointment as Assistant Professor, Veterinary Technology in Higher Education Department; and

**Whereas,** the Director Animal Husbandry, Kashmir vide No. PF-468/DAHK-Estb0PFS/159/2023-2-I/412810/2024 dated 24.06.2024 recommended the case for acceptance of technical registration asserting that there is no RDA/Vigilance Case or outstanding pending against Dr. Shabir Ahmad Bhat, Veterinary Assistant Surgeon.
