**Subject: Release of Grant in Aid under Centrally Sponsored Scheme "National Animal Disease Control Program (NADCP)".**

Sanction is accorded to release of Grant-in-Aid of ₹94,38,000/- (Rupees Ninety Four Lakh Thirty Eight Thousand) and ₹6,11,62,000/- (Rupees Six Crore Eleven Lakh Sixty Two Thousand) only in favour of Chief Executive Officer, Livestock Development Board (LDB's) Jammu/Kashmir through PFMS for procurement of Vaccination Accessories/ Logistics and Cold Chain Infrastructure under Central Sector Scheme "National Animal Disease Control Programme (NADCP)" for control of Foot & Mouth Diseases and Brucellosis for utilization during, financial year 2020-21, as per following break up:

The funds so allotted are released through Public Financial Management System (PFMS) in favour of Chief Executive Officer, Livestock Development Board Jammu/Kashmir.

**The above allotment/release is subject to following conditions:-**

- i) The Funds shall be utilized by the Livestock Development Boards in accordance with broad guidelines of the Scheme "NADCP" available on website [www.dahd.nic.in](http://www.dahd.nic.in).
- ii) The funds shall be utilized strictly following all codal formalities /GFRs in vogue.
- iii) Livestock Development Boards shall refund interest accrued from funds released under this scheme. As per Rule 230(\*) of GFR 2017," all interest or other earning against grant in aid should be mandatorily remitted to the consolidated funds of Government of India immediately instead of adjusting against future releases
- iv) Livestock Development Boards shall give details of district-wise physical and financial targets on basis of actual requirement for each district in the micro plan as indicated earlier.
- v) The Jammu & Kashmir State Implementing agency shall maintain subsidiary accounts of Government grant. The Ministry of Finance has formulated standard formats for presentation of final accounts by central autonomous organisation. The institute will maintain and present their annual accounts in prescribed formats.
- vi) The accounts of Jammu & Kashmir State Implementing Agency/ Livestock Development Board Jammu/Kashmir shall be open to inspection by sanctioning authority and central audit by Controller



- & Auditor General of India under the provision of C A & A.G (DPC) Act 1971 and internal audit by Pr. Accounts Office of the Ministry of Fisheries, Animal Husbandry & Dairying, Government of India.
- vii) The certificate of actual utilization of grants for the purpose for which it is sanctioned shall be submitted by Jammu and Kashmir State Implementing Agency in GFR 12A {Rule 238(1)} form towards the closure of financial year 202-21 through the State Government of Jammu & Kashmir alongwith component-wise statement of expenditure and quarterly progress report to Joint Secretary (LH) Ministry of Fisheries, Animal Husbandry & Dairying, Krishi Bhawan, New Delhi. Utilization certificates in above prescribed format shall also be uploaded on PFMS.
- viii) The list of items under "Cold Chain Infrastructure" for which funds are provided are as under:
- Walk in cooler/cold room
  - Ice Line refrigerator
  - Vaccine Carrier
  - Active cold cooling boxes (dual single chamber) at least one per block.
- ix) Performance-cum-Achievement report should be submitted after utilization of this grant.
- x) The assets acquired wholly or substantially out of Government grants except those declared as obsolete and unserviceable or condemned in accordance with the procedure laid down in GFR shall not be disposed off without obtaining prior approval of the designated authority which sanctioned the grant.
- xi) The Livestock Development Board Jammu/Kashmir should supply information on number of people belonging to schedule Castes, Scheduled Tribes and Women benefitted from the scheme on quarterly basis
- xii) The further use of Grant in Aid being released by this sanction Order, is to be done through EAT module of PFMS. The UC not supported by EAT module data is likely to be rejected and expenditure is not to be treated as regular. The agency would be forced to refund the amount received as the expenditure not appearing in EAT module data is not taken as expenditure incurred in accordance with the terms and conditions of this sanction order.
- xiii) No unspent balance is available with agency under the scheme. State has also submitted UCs for the funds released under earlier schemes of DADF.
