
**Government Order No: -08 -ASH of 2021

As recommended by J&K Public Service Commission, sanction is hereby accorded to the appointment of Fourteen (14) candidates as Veterinary Assistant Surgeons indicated at Annexure "A" to this Government order in Sheep Husbandry Department in the pay scale of Level-9 (52700-166700) under Jammu and Kashmir Probationer (Condition of service, Pay and Allowances) and Fixation of Tenure Rules 2020, notified vide S.O 192 dated 17.06.2020.

The appointee (s) shall report to concerned Director, Sheep Husbandry Department, Jammu/ Kashmir within a period of (21) days from the date of issuance of this order. In case, any appointee fails to join within stipulated period of 21 days, his/her appointment shall be deemed to have been cancelled without any further notice as per the circular No. 08-JK(GAD) of 2019 dated 04.12.2019.

The appointee (s) shall be allowed to join after production/ verification of following documents (in original):


1. Academic/Technical Qualification Certificate
2. Matriculation / DOB Certificate
3. Health Certificate by CMO
4. Domicile Certificate
5. Undertaking in shape of an affidavit along with attestation form in Annexure-1 of Government order No. 1328-GAD of 2016 dated 07.12.2016
6. Relevant category certificate
7. Certificate from concerned authorities to the effect that no loan under Self Employment Scheme has been obtained/ availed by the concerned candidate.
8. Any other relevant certificate as required under rules.

Further, the above appointment is provisional and subject to the fulfilment of following conditions:-

- (a) The Director, Sheep Husbandry Jammu/Kashmir shall verify the genuineness / recognition of the institution, educational qualification, internship, relevant category certificate / Domicile certificate and all other documents under rules. It shall be purely responsibility of Director concerned to verify the authenticity / genuineness of all the documents by following the due procedure as prescribed under law. If any adverse report that may come to the notice of the Department in respect of the appointee at later stage, then the responsibility shall be squarely upon the HoD concerned.
- (b) The appointee (s) shall give an undertaking in shape of affidavit to the effect that in case any adverse report about his/her character and antecedents is received from the Additional Director General of Police (CID), J&K, to whom a reference shall be made by the concerned Director. The candidate shall have no right to claim his/ her appointment as Veterinary Assistant Surgeon in Sheep Husbandry Department and his/her appointment as such shall be deemed to have been cancelled ab-initio.
- (c) The salary of the appointee (s) shall not be drawn and disbursed to them unless satisfactory report in respect of character and antecedents is received from the ADGP, CID and genuineness / recognition of the institution, educational qualification, internship, relevant category certificate / Domicile certificate and all other documents is received from the concerned authorities. Besides, if any certificate/ document of any candidate, so produced is found fake or forged, his/her appointment shall be deemed to have been cancelled ab-initio without further notice and the criminal action as warranted under rules shall be initiated against him/her.
- (d) The appointment of the above candidate shall be governed under Jammu and Kashmir Probationer (Condition of service, Pay and Allowances) and Fixation of Tenure Rules 2020, notified vide S.O 192 dated 17.06.2020.
- (e) The candidate(s) shall submit his/her joining report in the respective Directorates of Sheep Husbandry Department Jammu/Kashmir. The posting orders shall be issued by the Administrative Department separately, after fulfilment of conditions mentioned in this order.



- (f) The inter-se seniority of the appointee(s) shall be drawn in accordance with the merit secured in the selection list prepared by the J&K PSC.

This issues without prejudice to the outcome of the writ petition pending if any, before any competent court of law and shall be subject to the outcome of such writ petition.


