Subject: Discrepancies in the accounts of O/I ABS Pulwama

Whereas, Director, Animal Husbandry Kashmir, vide letter No. DAHK/Estt/387/8079 dated 17.08.2021 reported some discrepancies in the official accounts of O/I ABS Pulwama by way of undue debits/credits forged signatures;

Whereas, vide office order No. 570-DAHK of 2021 dated 08.07.2021 issued by the Director, Animal Husbandry Kashmir, a committee was constituted to enquire into the matter. The Inquiry Committee submits its report on 03.08.2021 which reveals that ABS Pulwama was operating its official business through two Bank Accounts viz 0474010200000040 & 0937040510000007 held at J&K Bank Branch TP Pulwama and Wushbugh respectively. The enquiry committee in its report has reported that ABS Pulwama has been provided with the funds by CEO LDB under NAIP & MAITRI in 03-2020 and examination of the records of the period has revealed that a hefty amount has been drawn from the official accounts of ABS Pulwama from 03-2020 to 06-2021;

Whereas, vide Government order No. 133-ASH of 2021 dated 14.09.2021, Dr. Anil Gupta, I/C Joint Director, IAH&BP Zakura, Kashmir was appointed as Inquiry Officer to conduct in-depth enquiry into the discrepancies in the accounts of O/I ABS, Pulwama who have submitted inquiry report, vide No. JD/IAH&BP/Enquiry/1101 dated 28.09.2021, where under it has been intimated that casual and carelessness approach of Dr. Abdul Rashid, Wani, (VAS), then I/C Officer Incharge, ABS Pulwama, and non reconciliation of accounts led to financial irregularities /discrepancies for the period 06-02-2019 to 28-07-2020, which could have been avoided, if the officer have given the attention/checks/reconciled with the bank in time.


