Subject: Notification of Avian influenza (H5N8) outbreak in domestic poultry at village Dalri, Block Rafiabad, District Baramulla.

NOTIFICATION the 14th of March, 2021

As reported by the National Institute of High Security Animal Disease Laboratory, Bhopal, vide letter No 15-100/2008-NISHAD, dated 13.03.2021, sample of domestic poultry bird from village Dalri, Block Rafiabad, District Baramulla has been found positive for Avian Influenza (H5N8) strain.

Therefore, in exercise of the powers vested under the provisions of the Prevention and Control of Infectious and Contagious Diseases in Animals Act, 2009 and instructions conveyed in Revised Action Plan for Prevention, Control & Containment of Avian Influenza- 2021, the outbreak of Avian Influenza (H5N8) disease is declared in village Dalri, Block Rafiabad, District Baramulla (bordering District Kupwara).

The outbreak of Avian Influenza disease in village Dalri, Block Rafiabad, District Baramulla is notified for all concerned in the Government of UT of J&K as well as concerned private and public agencies along with necessary guidelines and instructions.

The District Administration, Baramulla shall implement all contingency procedures at once for containment and control of bird flu in the area in collaboration with Deputy Commissioner Kupwara and all other concerned Departments.

Deputy Commissioner Baramulla shall notify the names of all villages and habitations within a radius of 0-1 KM from the epicenter of infection and designate it as "Infected Zone" and rest of the area 1 to 10 KM radius shall be designated as "Surveillance Zone".

Animal Husbandry Department, Kashmir shall conduct intense surveillance of Infected and Surveillance Zone. Culling operation shall be started as may be directed by Department of Animal Husbandry and Dairying, Gol. Director Animal Husbandry Department Kashmir and Deputy Commissioner Baramulla/ Kupwara shall strictly follow all the instructions as contained in "Revised Action Plan for Prevention, Control & Containment of Avian Influenza- 2021" (Copy enclosed) especially the instructions as mentioned in Chapter 3 of the Action Plan including declaration of infected and surveillance zones, Quick Start Coordination Process, establishment of Control Room, deployment of Rapid Response Teams (RRT's), availability of PPE's/ chemicals

/disinfectants, safety of personal engaged in control operation, destruction of poultry birds in infected zone, disposal of dead birds, imposition of legislative measures along with necessary measures laid down in the contingency plan (2005) of Ministry of Health and Family Welfare, GOI.

The Sanitization certificate shall be submitted after completion of all sanitization procedures and subsequently, "Post Operation Surveillance Plan" shall be implemented in the area in accordance to the instructions as may be conveyed by Department of Animal Husbandry & Dairying, Government of India, in this regard.
